- Places are subject to availability
- All relevant medical information must be declared at the time of application

Payments

- The swim school program operates in accordance with the NSW Public Schools Terms calendar
- Payment for the term must be made in full before the start of the first lesson. If payment has not been made admission to the lesson will not be permitted
- All Squad fees are due on or by the 1st of each month to secure placement
- All participants must present to reception prior to each lesson to record attendance
- Fees payable are subject to change at any time

Refunds and Make ups

- The swim school does not provide refund for missed lessons unless it is due to a facility closure
- The swim school does not provide make up classes, however we do give you a 15% discount if you enrol in swim vacation for that terms holidays.

General Swimmer Information

- The swim school recommends that all swimmers wear goggles and swim caps for hygiene and comfort reasons
- Children who are not toilet trained must wear a swim nappy for hygiene reasons
- The swim school requests that all parents respect time allocated to all swimmers. All enquiries concerning your swimmer and their class must be directed to the swim school office and not the staff teaching/coaching on pool deck.
- There is to be no swimming in the pool before or after lessons
